



DESCRIPTION

This product contains powerful d-limonene alternative ingredients come together to form a solvent strong enough to remove heavy duty buildup from a variety of surfaces.

Keep away from heat, hot surfaces, open flames, sparks. - No smoking. Keep container tightly closed. Ground/Bond container and receiving equipment. Use explosion-proof electrical, lighting, ventilating equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Avoid breathing mist, spray, vapors. Wash thoroughly after handling. Contaminated work clothing must not be allowed out of the workplace. Wear eye protection, face protection, protective clothing, protective gloves.

IF SWALLOWED: Immediately call a doctor, a POISON CENTER. Do NOT induce vomiting. **IF ON SKIN (OR HAIR):** Take off immediately all contaminated clothing. Rinse skin with water/shower. **If skin irritation or rash occurs:** Get medical advice/attention.
