DIRECTIONS FOR USE

The amount of cleaning solution required is determined by the length of beer or wine lines. For short lines, 1 quart is sufficient. Long lines require 2 to 3 quarts.

Use 1/2 to 1 ounce of Richco® BEER LINE CLEANER per quart of warm or cold water. Pump cleaning solution through the lines and rinse thoroughly with cold water or beer.

To clean faucets, disassemble and soap in cleaning solution, then rinse faucet parts with clean water before reassembling.
