Outdoor fogger for mosquito control: at a rate of 2.5 pints per acre (0.9 oz. per 1,000 sq ft.) using a ULV fogger.

May be sprayed or misted directly on livestock, poultry and dogs for fly and tick control.

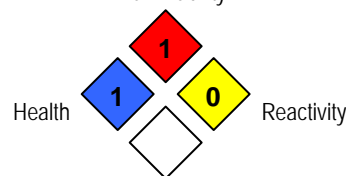
